HOW TO PLACE AN ORDER

1. The IC customer and its acquisition office create a Task Order Request Package (TORP) using eGOS, accessed from the LTASC website.
2. The TORP is then routed to the LTASC Support Team via eGOS for review and released to Contractors.
3. Contractors submit questions and proposals via eGOS.
4. IC customer evaluates Offerors' submissions and selects the Awardee.
5. The IC customer's acquisition office processes the task order award and the LTASC Support Team emails a signed Award Letter to the Awardee.
